Call to Order

Secretary's Report – October Minutes to be approved at the December Board Meeting.

Treasurer's Report – There is \$127,340 in checking and \$261,657 in CDs.

Member Business - None

Committee Reports

 \underline{ARC} – The current Architectural Review Committee (ARC) lacks participation and follow-through. The ARC is looking for new members to help shore up the committee.

Buildings and Maintenance - Smoke alarms were stolen from the clubhouse and need to be replaced.

<u>Landscape</u> – A tree was removed from the common grounds on Permit Court.

<u>Conservation Corps</u> – No report.

Neighborhood Watch - No report.

Newsletter – No report.

<u>Playgroup</u> – No report.

<u>Pool</u> – No report.

Old Business

- 300 of 537 (56%) lots have voted in favor of the Declaration Revision. 403 votes (75%) are needed to pass.
- Looking into using a key fob system to re-key the clubhouse.
- Electronic voting on HOA business is now allowed in the state of Virginia. The Board is working with KCHOA lawyers to create written procedures for electronic participation.

New Business

- The proposed 2022 budget was discussed and will be published in the December *Crier*. It will be voted on at the meeting on December 13.
- The Board of Directors appreciates input and leadership from the community in order to keep dues low by managing the HOA by community members. Board members are a requirement to self-govern. Please vote in the upcoming election.
- The KCHOA Administrative Assistant part-time paid position remains open. Or responsibilities could be split into two positions: one for the ARC and one for the HOA, or three positions: ARC, HOA, and bookkeeper.
- The marquee sign by the pool entrance needs to be replaced. It will not be electronic.

There was no Executive Session.




Please use the ballot below to cast your vote in the December Board of Directors election. Brief candidate bios are as follows:
